

# END USER LICENSE AGREEMENT FOR AVENSIA STOREFRONT AND SUPPLEMENTAL PRODUCTS

**IMPORTANT** - PLEASE READ THROUGH THE FOLLOWING TERMS AND CONDITIONS OF THIS END USER LICENSE AGREEMENT ("AGREEMENT") BEFORE INSTALLING AND/OR USING THE SOFTWARE AND PRODUCTS (AS DEFINED BELOW) IN ANY WAY.

BY INSTALLING, COPYING, DOWNLOADING, OR IN ANY OTHER WAY USING THE SOFTWARE, THE LICENSEE ACCEPTS THE TERMS AND CONDITIONS BELOW AND THIS AGREEMENT BECOMES A BINDING OBLIGATION ON THE LICENSEE. IF THE LICENSEE DOES NOT AGREE TO THESE TERMS AND CONDITIONS, DO NOT INSTALL, COPY, DOWNLOAD, IN ANY OTHERWAY USE THE SOFTWARE, OR OTHERWISE INDICATE REFUSAL, AND MAKE NO FURTHER USE OF THE SOFTWARE.

## 1. Definitions

"Agreement" means this End User License Agreement.

"Applied Software" means the third party software listed in Section 11 below.

"Development Licenses" means a limited License Type that can only be used for non-commercial purpose(s). These cannot be used for any public facing Site or Server and are typically labeled as, but not limited to, "Partner", "Developer", "Demo", "Demonstration" or "Evaluation" license(s). Developer Licenses are limited to Site usage restrictions.

"Documentation" means Avensia Storefront AB's written material or files describing the Software and which is delivered together with the Software.

"Implemented Software" means the implemented third party software listed in Section 11 below which have been implemented as part of the Products.

"Licensee" means the party licensing the Software from Avensia in accordance with this Agreement.

"License Type" means the license types provided by Avensia Storefront AB from time to time.

"Products" means the product Avensia Storefront and supplemental products provided by Avensia Storefront AB as further described in Section 2.1 and 2.2 below.

"Site" means a site set up in Episerver. Each Episerver site has one unique start page under the Episerver root node. This information can be found in Episerver under the [CMS] tab, then [Admin], then [Config], then [Manage Websites]. In this view, under [Manage Websites], each Site listed under [Websites] constitutes one (1) Site. The number of Site(s) the Licensee runs, in turn, will affect the number of license(s) for the Software that must be purchased by the Licensee.

"Software" means (i) all of the contents of the files, CD-ROMs or other media in machine-readable form provided under this Agreement, including (a) all software provided by Avensia Storefront AB (b) Applied Software, (c) Implemented Software (d) Third Party Products, (ii)

Documentation; but excluding any part of the original source code of the Implemented Software. Code covered by this document is limited to compiled machine-readable code and therefore excludes any editable code such as, but not limited to, example code, start up site code, markup, etc.

"Third Party Products" means third party software provided by a third party which may be installed together with the Software.

"Use" means to access, install, download and/or execute the Software in order to utilize the functionality of the Software.

## 2. General

2.1 The Software is licensed, not sold, to the Licensee by Avensia Storefront AB for use only under the terms of this Agreement. The terms of this Agreement will govern any software upgrades or updates provided by Avensia Storefront AB that replace and/or supplement the original Software or parts thereof, unless such upgrade or update is accompanied by a separate license in which case the terms of that license will govern.

## 3. Software License

3.1 Subject to the terms and conditions of this Agreement and subject to the Licensee making full and timely payment of all fees and charges, Avensia Storefront AB grants the Licensee a non-exclusive, non-transferable limited license to use the Software solely for the Licensee's internal business purposes.

- **General Use of Products.** The condition for general use differs depending on the Product and the terms and conditions for the License Type acquired by the Licensee. Additional definitions, terms, conditions and restrictions will apply depending on license type, and can be found on Avensia Storefront AB License Types and General Terms and Conditions. Avensia Storefront AB presently offers the following Products with the following licenses; Avensia Storefront Production license, Demo license and Development license

3.2 **General Use of Supplemental Products.** Avensia Storefront AB presently offers the following Supplemental products on the following conditions:

(i) Packages of software. The Licensee may install the Software on multiple servers serving only (1) site per license unless License Type states otherwise. License Types covering multiple sites may be available.

Packages of software can only be used in combination with a Product on the terms and conditions for the License Type acquired. Packages of software may include Third Party Software and require acceptance of other end user license agreements.

3.3 **Backup copy.** The Licensee may make one (1) backup machine-readable, object code copy of the Software for nonproductive, archiving purposes.

3.4 **Modifications.** The Licensee may modify the Software solely as is necessary for the use of the Software in accordance with its intended purpose. Avensia Storefront AB shall have no liability for any such modification or for any fault or error caused by it. Avensia Storefront AB recommends that the Licensee implements such modifications with the assistance of a developer certified by Avensia Storefront AB.

3.5 **Service Channel.** The Avensia Storefront AB Software provides services for license key installation and updates, security announcements and other information. To be able to provide these services the following information might be transmitted and stored at Avensia Storefront AB: License key information, software version, hostname (website URL), host IP/MAC address and machine name

#### 4. **Restrictions**

4.1 **Non-transfer.** Except as expressly authorized in this Agreement, the Licensee shall not hire out, lease, lend, assign, sublicense, distribute (electronically or otherwise), resell, sell, create any derivative works of, or otherwise transfer all or any portion of the Software to another party.

4.2 **Decompilation.** Except as expressly authorized in this Agreement, by prior written permission given by Avensia Storefront AB, or to the extent expressly permitted by applicable law, the Licensee shall not copy, modify, reverse engineer, decompile, disassemble, translate, make works derivate of the Software or otherwise attempt to discover the source code of the Software. Any attempt to do so is a violation of the rights of Avensia Storefront AB and its licensors of the Software and will result in an immediate revocation of the license rights granted in this Agreement. The Licensee may request permission from Avensia Storefront AB to decompile the Software for purposes of fault analysis, integration planning and other internal business purposes. Such permission may be granted by Avensia Storefront AB in writing and at its sole discretion.

4.3 **Redirect.** The Software shall not be used in solutions that use an internal redirect (automatic server side or client side rerouting of traffic) for purposes of circumventing Avensia Storefront AB license restriction software, code, processes, and/or methods.

#### 5. **Ownership and Intellectual Property Rights**

5.1 This Agreement does not imply the passing of any intellectual property right or part of such right to the Licensee, except the right of use specified in this Agreement. Avensia Storefront AB and its licensors retains the sole and exclusive ownership of all rights, title and interests in and to the Software, the Documentation and all copies and derivative works thereof (regardless of form or media in or on which the original and other copies may exist), including all copyright, trademark, patent, trade secret, know-how and other intellectual property rights pertaining thereto. Avensia Storefront AB retains all rights to its name and trademarks.

5.2 The Software is protected by Swedish and international copyright legislations.

5.3 This Section 4 shall survive termination of this Agreement.

## **6. Security**

- 6.1 The Licensee shall pay special attention to security aspects related to the Software in connection with the use of the Internet. Gaps in security may exist or be discovered in the Software related to such use. The Licensee shall carefully follow up and monitor developments within the field, in order to ensure security in connection with the use of the Software. Additionally, small errors or mistakes in configuration and/or installation may cause or result in security problems. Avensia Storefront AB hereby disclaims any and all liability for any security issues related to the Licensee's use of the Software.

## **7. Limited Warranty, Limitation of Liability and Indemnification**

- 7.1 For a period of thirty (30) days following delivery of the Software, Avensia Storefront AB warrants that the Software will perform substantially in accordance with the Documentation supplied by Avensia Storefront AB together with the Software. Avensia Storefront AB's sole and exclusive obligation and/or liability for breach of this limited warranty shall be to use its commercially reasonable efforts to remedy or supply a temporary fix of the deficiencies, or to make an emergency bypass. To the extent Avensia Storefront AB is not able to remedy the deficiencies as provided in the forgoing sentence Avensia Storefront AB shall refund to the Licensee the fee paid for the Software. This limited warranty shall not be valid if the Software was subjected to abuse, misuse, accident, alteration or unauthorized modification or installation. Other than this limited warranty, the Software is provided AS IS.
- 7.2 EXCEPT AS SET FORTH IN SECTION 7.1 AND TO THE MAXIMUM EXTENT ALLOWED BY LAW, AVENSIA STOREFRONT AB MAKES NO WARRANTIES OR REPRESENTATIONS, EXPRESS OR IMPLIED, WHETHER BY STATUTE, COMMON LAW, CUSTOM, USAGE OR OTHERWISE AS TO ANY MATTERS, AND SPECIFICALLY DISCLAIMS ANY WARRANTY OF MERCHANTABILITY, INTEGRATION, SATISFACTORY QUALITY, OR FITNESS FOR ANY PARTICULAR PURPOSE. WITHOUT LIMITING THE GENERALITY OF THE FOREGOING, AVENSIA STOREFRONT AB DISCLAIMS ANY REPRESENTATIONS OR WARRANTIES THAT THE SOFTWARE WILL OPERATE UNINTERRUPTED OR ERROR FREE. NO ORAL OR WRITTEN INFORMATION OR ADVICE GIVEN BY AVENSIA STOREFRONT AB, ITS DEALERS, DISTRIBUTORS, RESELLERS, AGENTS, OR EMPLOYEES SHALL CREATE A WARRANTY OR IN ANY WAY INCREASE THE SCOPE OF THIS WARRANTY, AND THE LICENSEE MAY NOT RELY ON ANY SUCH INFORMATION OR ADVICE.
- 7.3 UNDER NO CIRCUMSTANCES SHALL AVENSIA STOREFRONT AB, NOR ANYONE ELSE WHO HAS BEEN INVOLVED IN THE CREATION, PRODUCTION OR DELIVERY OF THE SOFTWARE OR PRODUCTS, HAVE ANY LIABILITY OF ANY KIND TO THE LICENSEE, ANY AUTHORIZED USER OR ANY OTHER PERSON FOR ANY SPECIAL, INCIDENTAL, CONSEQUENTIAL PUNITIVE OR OTHER INDIRECT LOSSES OR DAMAGES (EVEN IF AVENSIA STOREFRONT AB HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH POTENTIAL LOSS OR DAMAGE), INCLUDING, WITHOUT LIMITATION, LOSS OF PROFITS, LOSS OF DATA OR INFORMATION, BUSINESS INTERRUPTION OR ANY OTHER COMMERCIAL LOSSES ARISING OUT OF OR RELATED TO ANY ACT OR OMISSION OF ANY KIND HEREUNDER BY AVENSIA STOREFRONT AB, ANY ACCESS TO

OR USE BY THE LICENSEE OR ANY OTHER PERSON OF THE SOFTWARE, REGARDLESS OF THE THEORY OF LIABILITY (CONTRACT, TORT OR OTHERWISE). UNDER NO CIRCUMSTANCES SHALL AVENSIA STOREFRONT AB'S AGGREGATE LIABILITY TO THE LICENSEE FOR LOSSES OR DAMAGES OF ANY KIND EXCEED AN AMOUNT EQUIVALENT TO THE AGGREGATE OF ALL FEES PAID BY THE LICENSEE FOR THE SOFTWARE OR PRODUCT AT ISSUE.

- 7.4 With respect to faults and errors in any Third Party Products, the Licensee must contact the relevant third-party supplier. In respect of Third Party Products the relevant third-party terms and conditions shall apply. Avensia Storefront AB disclaims all warranty and all liability for any faults or errors in any Third Party Products or related to the use of the Software in conjunction with any such Third Party Products.
- 7.5 The Licensee agrees to indemnify, defend and hold Avensia Storefront AB, its officers, director, agents, representatives and employees harmless from any claim, liability, loss, expense or demand, including legal fees and costs and including without limitation claims based on copyright infringement, arising out of or related to the Licensee's modifications of the Software or the Licensee's merging or including the Software with other software or any other violation of this Agreement by the Licensee.

## **8. Support**

- 8.1 No support, upgrades or updates of the Software are provided or included under this Agreement. Software updates may be provided by Avensia Storefront AB, subject to a separate Software subscription agreement with Avensia Storefront AB. Technical support for the Software may be provided by the reseller from which the Licensee purchased the Software or by Avensia Storefront AB, subject to a separate support agreement with such reseller or Avensia Storefront AB, as applicable. Please check with the reseller of the Software regarding any such support services.

## **9. Termination**

- 9.1 This Agreement is effective until terminated. The Licensee's rights under this Agreement will terminate automatically or otherwise cease to be effective without notice from Avensia Storefront AB if the Licensee fails to comply with any terms and condition of this Agreement. Upon such termination, the Licensee shall cease to use the Software and delete all copies thereof. Upon Avensia Storefront AB's request, the Licensee shall certify in writing to Avensia Storefront AB that the Licensee does no longer use the Software and that any copy thereof, including all Documentation, has been destroyed.
- 9.2 If Avensia Storefront AB, by any reason, no longer should have the necessary licenses for the Implemented Software or the Applied Software Avensia Storefront AB shall within a reasonable time and with reasonable commercial effort provide a substitute for such software. If no such substitute may be found, Avensia Storefront AB may, at its own option, terminate the license and return any license fee to the user minus any depreciation in the value of such software.

9.3 Sections 4.1, 5 and 10 shall survive termination of this Agreement.

## **10. Governing Law and Dispute Resolution**

10.1 This Agreement shall be governed by and construed in accordance with the substantive laws of Sweden.

10.2 Any dispute, controversy or claim arising out of or in connection with this contract, or the breach, termination or invalidity thereof, shall be finally settled by arbitration in accordance with the Rules for Expedited Arbitrations of the Arbitration Institute of the Stockholm Chamber of Commerce. The place of arbitration shall be Lund, Sweden.

## **11. General provision**

11.1 The following contractual documents shall apply between Avensia Storefront AB and the Licensee and form part of this Agreement: (i) This Agreement and (ii) Avensia Storefront AB License Types and General Terms and Conditions. In case of any discrepancy or inconsistency between the contractual documents, the documents shall prevail in the order listed above, unless the circumstances clearly induce otherwise.

11.2 By agreeing to this Agreement the Licensee also acknowledges that the license agreements for the above listed software and MIT/BSD licensed components have been made available at [http://www.episerver.com/implemented\\_software](http://www.episerver.com/implemented_software); that the Licensee has taken notice of said license agreements; and that the Licensee hereby accepts the terms and conditions of these license agreements to be, when applicable, binding to the Licensee.

11.3 No amendment of or modification to this Agreement will be binding unless made in writing and signed by Avensia Storefront AB.

11.4 This Agreement is valid for any version(s) of the Software released after version 1.0. Avensia Storefront AB reserves the right to amend the terms and conditions of this Agreement for any upcoming versions of the Software.

11.5 The Licensee shall not assign this Agreement without Avensia Storefront AB's prior written consent, which consent may be withheld for any or no reason. Either party may assign all or part of its rights under this Agreement to an affiliate under its control or to any entity that succeeds to or acquires all or substantially all of the business or assets of such party through a merger, consolidation, or acquisition of stock or assets. This Agreement is binding on any permitted assignees.

11.6 If for any reason any provision in this Agreement, or portion thereof, would be found unenforceable, the remainder of this Agreement shall continue in full force and effect.

## **12. Implemented Software**

12.1 The following software are Implemented Software.

(i) Private port of Lucene dot net, Open Source, (Apache Software License); (ii) Log4net, Open Source, (Apache Software License Version 2.0); (iii) Simple CSS Parser, (Code Project Open License 1.02); (iv) CommonServiceLocator, (Microsoft Public License (Ms-PL)); (v) Structure Map, (Apache Software License Version 2.0); (vi) NuGet Packet Manager, (Apache Software License Version 2.0); (vii) Castle Project - Core 2.5.2, (Apache Software License Version 2.0); and (viii) EFExtensions, (Microsoft Limited Public License).

## **13. Compatibility**

As between Avensia Storefront AB and the Licensee Section 6, 7, 8 and 10 shall also apply with respect to the Implemented Software, unless the license on the specific Implemented Software explicitly states otherwise.
